

## INVITATION TO BID

THE CITY OF MANCHESTER, TN WILL ACCEPT SEALED BIDS FOR WEIGHT ROOM FLOORING REPLACEMENT FOR THE MANCHESTER REC CENTER. ALL BIDS MUST BE RETURNED WITH AN ORIGINAL AND A COPY, SEALED TO THE FINANCIAL OFFICE NO LATER THAN FEBRUARY 23<sup>RD</sup> AT 10:00A.M. MANCHESTER CITY HALL, 200 FORT STREET, MANCHESTER, TN 37355.

THIS PROJECT INCLUDES THE REMOVAL AND REPLACEMENT OF FLOORING AND WALL BASE IN THE WEIGHT ROOM OF AN EXISTING RECREATION FACILITY. NEW FLOORING AND WALL BASE SHALL BE RUBBER PRODUCTS. THE CONTRACTOR SHALL BE RESPONSIBLE FOR MOVING AND RELOCATING SPORTS EQUIPMENT ON SITE AS NECESSARY TO COMPLETE THE WORK. CONTRACTOR IS RESPONSIBLE FOR DELIVERING, RECEIVING, UNLOADING, AND STORING ALL MATERIALS ON SITE.

BIDDERS MUST BE LICENSED CONTRACTORS AS REQUIRED BY THE CONTRACTOR LICENSING ACT OF 1976 (T.C.A. TITLE 62, CH. 6). NO BID WILL BE OPENED UNLESS THE SEALED ENVELOPE CONTAINING THE BID PROVIDES THE FOLLOWING INFORMATION: THE CONTRACTOR'S LICENSE NUMBER, THE DATE OF THE LICENSE'S EXPIRATION, THAT PART OF THE CLASSIFICATION APPLYING TO THE BID, AND OTHER INFORMATION REQUIRED BY LAW.

IT IS THE POLICY OF THE CITY OF MANCHESTER TO ENSURE COMPLIANCE WITH TITLE VI OF THE CIVIL RIGHTS ACT OF 1964; 49 CRF, PART 21. NO PERSON SHALL BE EXCLUDED FROM PARTICIPATION IN OR BE DENIED THE BENEFITS OF, OR BE SUBJECT TO DISCRIMINATION UNDER ANY PROGRAM OR ACTIVITY RECEIVING FEDERAL FINANCIAL ASSISTANCE ON THE GROUNDS OF RACE, COLOR, SEX, AGE, DISABILITY, OR NATIONAL ORIGIN.
