**A RESOLUTION TO APPROVE A CONTRACT IN THE AMOUNT OF ONE MILLION ONE HUNDRED AND EIGHTY SEVEN THOUSAND NINE HUNDRED FIFTY AND 00/100 DOLLARS(\$1,187,950.00) WITH C AND H CONTRACTORS INC. FOR BALLFIELD LIGHTING AND ADA IMPROVEMENTS, PROJECT #102-181**

WHEREAS the City of Manchester solicited bids for the provision of new ballfield lighting and ADA improvements, Project #102-181; and

WHEREAS the bids were reviewed by the City's Engineer and, by letter dated February 1<sup>st</sup>, 2024, he recommended acceptance of the low base bid of C and H Contractors Inc. for Project #102-181; and
